## Basketball (Full Court) Endorsement

---

By endorsement, the following changes are made to **Your Policy**:

---

### Definitions

---

The definition of **Specified Event** is deleted in its entirety and is replaced by the following:

**Specified Event** occurs when a **Contestant** who complies with the **Conditions of Participation** shoots (from the **Backcourt Baseline**) a **Basketball** through the **Ring** on the full without the **Basketball** bouncing or coming into contact with the backboard support beams or ropes and **You** have promised to give the **Contestant** the **Prize**.

The following additional definitions are included in **Your Policy**:

**Backcourt Baseline, Frontcourt** and **Sideline** have the meanings attributed to them respectively in the **Rules of Basketball**.

**Ring** means a basketball ring situated at the **Frontcourt Baseline** of the **Court** which is 45 centimetres in diameter and is raised 3.05 metres above the floor.

**Basketball** means a size 7 basketball.

**Court** means a basketball court:

- a) where the **Baseline** is at least 14 metres long; and
- b) **Sideline** is at least 26 metres long.

**Rules of Basketball** means the Official Basketball Rules in force at the time of the **Contest** as published from time to time by the Fédération Internationale de Basketball.

## Section 2: Conditions – Your Obligations

The following additional conditions are included in **Your Policy** following clause 2.4:

2.5 **Contestants** must be selected at random.

## Section 3: Conditions of Participation

---

The following additional conditions of participation are included in **Your Policy** following Clause 3.1(e):

- f) any person who, at any time has registered with or played with any professional or semi-professional club, College, University, State or National team.

The following additional conditions of participation are included in **Your Policy** following Clause 3.4:

3.5 The **Contestant** must be facing the **Ring** when they attempt to shoot the **Basketball**.

3.6 If any of the following occurs, then the **Contestant** has not complied with the **Conditions of Participation** and is disqualified:

- a) the **Contestant** attempts more than one shot during the **Contest**;
- b) the **Contestant** takes a practice shot during the **Contest**; and/or;
- c) the **Contestant** takes more than 30 seconds to shoot the ball during the **Contest**.

## Basketball (Half Court) Endorsement

By endorsement, the following changes are made to **Your Policy**:

### Definitions

The definition of **Specified Event** is deleted in its entirety and is replaced by the following:

**Specified Event** occurs when a **Contestant** who complies with the **Conditions of Participation** shoots (from the **Backcourt**) a **Basketball** through the **Ring** on the full without the **Basketball** bouncing or coming into contact with the backboard, support beams or ropes and **You** have promised to give the **Contestant** the **Prize**.

## Section 3: Conditions Of Participation

---

The following additional **Conditions of Participation** are included in **Your Policy** following Clause 3.1(e):

- f) any person who, at any time has registered with or played with any professional or semi-professional club, College, University, State or National team.

The following additional **Conditions of Participation** are included in **Your Policy** following Clause 3.4:

- 3.5 If a **Contestant** is under 12 years of age, the **Contestant** can substitute another person to enter into the **Contest** for them, provided that the second mentioned person is otherwise eligible to be a **Contestant**.
- 3.6 The **Contestant** must have one foot inside the **Backcourt** and one foot outside the **Court**.

3.7 The **Contestant** must be facing the **Ring** when they attempt to shoot the **Basketball**.

3.8 If any of the following occurs, then the **Contestant** has not complied with the **Conditions of Participation** and is disqualified:

- a) the **Contestant's** feet leave the ground during their attempt;
- b) the **Contestant** attempts more than one shot during the **Contest**;
- c) the **Contestant** takes a practice shot during the **Contest**; and/or;
- d) the **Contestant** takes more than 30 seconds to shoot the **Basketball** during the **Contest**.

All other terms, conditions, exclusions and limitations contained in **Your Policy** remain unchanged.
